## GIVEAWAY CONTEST RULES

### General Terms and Conditions Giveaways

No Purchase Necessary.

Entry into **Santa's Enchanted Forest Ticket Giveaway Competition** is deemed acceptance of these terms and conditions.

1. Open to US entrants who are 18 years of age or older at the time of entry. Minors may have a guardian assist them and enter on their behalf. The Promoter is Santa's Enchanted Forest located in Miami, Florida, USA.

2. The officers, management and employees (or immediate family of an officer, manager or employee) of the Promoter, the agencies associated with this Competition and their related bodies corporate are not eligible to enter this giveaway.

3. The Competition Entry Period begins **November 4, 2021 at 12:00 am Eastern Time and closes December 23, 2021 at 11:59 pm Eastern time**. Five (5) Winners will be chosen weekly and notified by the email they registered with. Weekly drawings will close on Friday, November 11, 18, 25, December 2, 9, 16 and December 23, 2021. Winners will be announced on or before the next Monday following the drawing date. Entrants must re-enter weekly to be considered in subsequent drawings.

4. To enter the Competition and be eligible to win, entrants must:  
A) Simply follow the instructions. No purchase necessary. Void where prohibited or restricted by law. Odds of winning a prize are dependent upon the total number of eligible entries received. Prizes are limited to **one (1) winner per household, per season**.

The type of prize offered by the promoter will be **Two Single Day Tickets. A Santa's Single Day Ticket** allows access to bearer to a single one-day admission during the 2021 event season. Prizes from this giveaway are only valid for the 2021 event season. All giveaway tickets expire January 2, 2022.

7. The winner(s) of the prize(s) will be drawn at random from all valid entries received by the end of the giveaway using Rafflecopter or Random.org.

### Winners

8. Promoter will email the winner(s) at the email address used to sign up and register for the giveaway. It is up to the entrants of the giveaway to check their emails to see if they have won.

9. If a Prize winner cannot be contacted or does not claim the Prize within 72 hours from the date they were notified, then the Prize will be forfeited and a substitute prize will not be offered in lieu of the Prize.

10. By entering this giveaway, entrant agrees to have their name published on the promoter's website/Google Plus/Twitter/Facebook and other social media sites should they win a prize.

11. Winners shall respond via return email message to Santa's Enchanted Forest with the name that appears on their driver's license or other valid government issued ID. Instructions will then be sent to the provided email address on how to claim the winning pass(es).

12. Each Single Day Ticket covers only one person and is not transferable once issued.

15. The Winner releases Santa's Enchanted Forest of any liability for a lost confirmation email/voucher or for failing to review Santa's Enchanted Forest terms of service.

16. Winner agrees that he/she entered said giveaway at their sole risk. ### General
