# Terms and Conditions: Toy Drive and Holiday Celebration Giveaway

# Ending December 15, 2023

# 1. Eligibility:

# 2. Promoter:

- Entry into the Giveaway Competition is deemed acceptance of these terms and conditions.

### 3. Ineligibility:

• The officers (or immediate family of an officer) of the Promoter, the agencies associated with this Competition, and their related bodies corporate are not eligible to enter.

# 7. Deadline for Entry:

- All entries must be received by 5:30 PM EST on December 15, 2023.
- Entries received after this date and time will not be considered.

#### 8. Claiming the Prize:
